2026 RESIDENTIAL LED BULB REBATE PROGRAM (CIP #11)

Qualifying Customers

AMU residential customers are eligible for rebates when purchasing and installing new Light-Emitting Diode (LED) light bulbs to be used where the electricity is supplied by AMU.

Rebate Details

AMU will issue rebate in the form of account credit to the customer. AMU Home Lighting Rebate Program will help you get the most out of your lighting dollars. Here is how you will benefit:

- Reduced bulb upgrade cost because of rebate
- Reduced energy cost since LED's use less electricity
- Reduced replacement costs since LED's have a longer rated life than incandescent bulbs.

String lights and other décor do not qualify for this rebate and all submissions will be at AMU's discretion.

Application Details

Customers must apply for rebates within twelve months of the purchase date shown on the sales receipt. Applications must include:

- Customer information: Name, Address, Phone Number, and AMU account number.
- Copy of original store-identified dated sales receipt/invoice.
- Must replace bulbs at the address with Anoka Municipal Utility (AMU) service.
- Rebate for each energy saving LED is the cost of the bulbs up to a **Limit of \$50.00 per customer per year.**
- Bulbs do not have to be Energy Star®, but must show energy savings (replaces higher wattage bulbs).

Failure to complete this information will result in a rejection of the application. Rebate qualifications and amounts are subject to change at any time. AMU conservation rebate programs may be cancelled or changed without notice. AMU customers should check with AMU to determine whether program changes have occurred.

Bulbs must be installed where electric service is provided by AMU on a retail basis. Rebate program is subject to change without notice.
