**BUILDING PERMITS**

*The administration and issuance of permits and the collection of fees shall be as authorized in Minnesota Statutes, Chapter 326B, Minnesota Administrative Rules 1300.0120 and 1300.0160, and as provided by this fee schedule. Fees are to commensurate with the service provided. Permit fees not specifically identified within this fee schedule are based on the valuation.*

**Project Value Determination:** The Designated Building Official has the authority and responsibility to determine project valuation for the purposes of establishing applicable plan review and permit fees. Valuation data may be referenced from the State of Minnesota and/or the International Code Council.

**Plan Review Fees:** Plan review fees for building permits shall be sixty-five percent (65%) of the building permit fees as set for in Table A. Plan review fees for similar plans are set forth in Minnesota Rules 1300.0160. If submitted permit applications have had a plan review completed and the project canceled, plan review fees may still be assessed.

**State Surcharge on Permits.** In addition to the permit fees established in this fee schedule, a surcharge fee shall be collected on all permits issued for work governed by the Minnesota State Building Code in accordance with Minnesota Statutes, Section 326B.148.

If the fee for the permit issued is fixed, the surcharge amount is \$1.00. For all other permits, the State of Minnesota surcharge is as follows:

**BUILDING PERMITS (CONTINUED)**

**Refund of Permit Fees (ref. MN Rules 1300.0160, Subd. 9).** The City may refund fees for permits on which no work has been completed and no inspections have been made. Requests for refunds must be in writing and signed by the permit holder. The Building Official or its appointee must approve each refund and the City shall retain the following:

\$60.00	For requests made within 30 days, fee totals less than \$60 are non-refundable
\$60 or 20% of the permit fee, whichever is greater	For requests made within 60 days

\$60 or 60% of the permit fee, whichever is greater	For requests made within 120 days
\$60 or 80% of the permit fee, whichever is greater	For requests made within 180 days

**No refunds will be approved or granted for the following: plan review fees, state surcharge fees, re-inspection fees, or any other services that have previously been rendered.**

**Validity, Expiration and Suspension or Revocation of Permits.** The validity, expiration, and suspension or revocation of permits shall be as provided by MN Rules 1300.0120, Subparts 10, 11, and 12 or as defined in Chapter 18 of the Anoka City Code.

**Work Begun with a Permit.** When work requiring a permit has been commenced without first obtaining a permit, a special investigation shall be made before permit may be issued for such work. An investigation fee, in addition to the permit fee shall be collected whether or not a permit is then or subsequently issued. The investigation fee may be equal to the amount of the permit fee required.

Plumbing plan review and permit fees shall be paid prior to issuance and commencement of work. The City charges the following fees for plan reviews and audits of plumbing installations for public, commercial and industrial buildings.
